## MURDOCH ABANDONS TAKEOVER OF SUMMER INSTITUTE

PURCHASE ATTEMPTS EXTEND TO THE UNITARIAN-UNIVERSALIST ASSOCIATION ITSELF

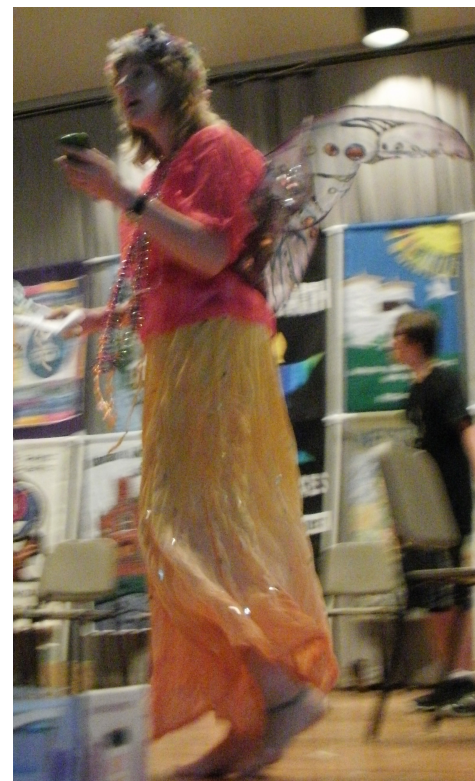
The situation improved when the SI Fairy was called to appear in court to present her libel case against the Mockingbird™, but was unable to actually appear.
